FROM MAYOR SHARKEY

Ahhh... the Summer season is finally upon us! Time for outdoor barbecues, gathering with family and friends and simply enjoying this time of year. First up, a brief reminder about fireworks. Remember that fireworks are prohibited by state law within 150 feet of buildings and occupied structures, making them illegal in many residential areas in the Borough. Next, I'd like to dedicate some attention to our upcoming trash and recycling contract. Our current contract with Penn Waste expires at the end of January 2024. Council is evaluating several different options to be included in the bid process based on the feedback received from the major trash haulers in the County. The main provisions of our current contract include two pickups a week using our own trash cans/containers, optional extra bags for yard waste in the fall and bulky trash item pickup. The haulers have expressed concerns related to being able to continue at the same service level. We should be aware that there is a big push on the hauler side to transition to the large trash "toters" to allow for more automated pickup. In addition, we should expect having two pickups a week will add significant extra expense. As the process progresses, it will be important to provide feedback to Council. Our neighbors in New Freedom recently switched to the large toters and it has generated considerable negative feedback in their community. Thanks for letting me bend your ear on this topic. I hope you have a wonderful summer and look forward to seeing you at the Fire Company's carnival! Thank you for doing your part in helping to make Shrewsbury a great place to live!

FIREWORKS SAFETY AND RESTRICTIONS.

As we kickoff the summer season, it's a good time to remind everyone while fireworks are usually fun to watch, they can be extremely dangerous and bring excess noise. Again, State law prohibits the use of fireworks within 150 feet of buildings and occupied structures, which makes them illegal in most neighborhoods throughout Shrewsbury Borough. In addition, our nuisance ordinance prohibits fireworks in legal locations from being used after 10:00 pm. When you're using fireworks legally, please keep your personal safety as well as the safety of those around you in mind. Fireworks can cause serious injuries which have also increased in the past few years.

PRACTICE WATER CONSERVATION

Water conservation is an excellent practice to reduce your water and sewer bill and protect Shrewsbury's most precious resource. Water and sewer are billed based on water usage and water meter readings.

Water Conservation Tips:

- · Check water meter periodically to make sure there are not any leaks in your house. Some leaks (toilets) may not be heard and must be checked with the meter. The Public Works Department can teach you to read the meter and analyze readings.
- Do not use the toilet as a garbage can. Some toilets use five to seven gallons of water with every flush
- Use dishwasher and washing machine when you have a full load - will save five to 15 gallons per wash.
- · Keep a container of drinking water in refrigerator instead of allowing water to run to cool for drinking.
- · Turn water off when brushing teeth.
- Limit your shower to less than five minutes. Conservation can potentially save one thousand gallons of water per month.
- · Showers (10-25 gallons) use less water than baths (70 gallons).
- · Water plants during coolest parts of the day (morning or evening) to avoid evaporation.
- · Cover the swimming pool to eliminate evaporation.
- · Mulch outdoor plants to help with soil moisture.
- Purchase and install a rain barrel for watering to capture rainwater.
- · Use a broom instead of water to clean your driveway, porch, or sidewalk.
- Mow your yard to 3" height for a deeper root structure and avoid watering grass.
- · Be smart, save money, and use water wisely!!!

WATER METER USAGE AWARENESS

Shrewsbury Borough finished a water meter replacement program in 2020. Our goal is to replace water meters every 25 years or 2,000,000 gallons water usage. Most residential water meters are located in your home and we have three different water meter styles in our system. The Public Works Department can help you read your own water meter to monitor usage and practice water conservation. WATER MAIN FLUSHING

The south water system mains will be flushed between 8:00 a.m. and 6:00 p.m. on Monday, July 10th and Tuesday, July 11th.

The South System is south of 304 South Main Street including: Messina Court, 50 East Church Avenue, 249 South Main Street, and 301 South Main Street.

The Public Works Department operates all water valves and hydrants throughout our entire water system.

- The water flushing removes dirt and debris from the water mains. Prevents water stagnation and taste and odor problems.
- · Verifies fire hydrant operation and water system flow and pressure.
- · Verifies water valve operation.
- · Safe and high-quality water delivered to customers.

Water discoloration will occur during the scheduled times so please avoid doing laundry, using hot water, and drinking tap water until the water is completely clear.

FIRE HYDRANT WATER THEFT

The Public Works Department and Fire Company are the only authorized fire hydrant users. Fire hydrant water theft increases customer rates, allows for potential water contamination, damages fire hydrants, and lowers water pressures for fighting fires. SPOTLIGHT: THE ZONING HEARING BOARD



The Zoning Hearing Board consists of Borough residents that are appointed by Shrewsbury Borough Council to act as a local court for zoning and land use matters. The Board consists of four residents (3 members and an alternate) that decide challenges to the zoning ordinance. The Board has ruled on many different issues as Shrewsbury has rapidly grown over the last 40 years. The most recent rulings include zoning variances and wellhead protection issues. The wellhead protection rulings protect the Borough's groundwater with measures that prevent water overuse and contamination. The Board also

interprets the Zoning Ordinance and decides on land use matters.

John Morrell is the current Chairman of the Zoning Hearing Board and lives in the Village area of Shrewsbury Borough for almost 30 years with his wife, Nancy. They live in a pre-Civil War home that fronts Main Street. John has almost 30 years of experience on the Zoning Hearing Board and presides with a detailed and meticulous manner. The other Zoning Hearing Board members are Lee Milstead and John Speights with Nelson Alpaugh serving as the alternate. Lee Milstead is a long time Borough
